1. Please refer to your letter on the subject mentioned above.

2.This Office has no objection to the construction of the proposed Residential building by M/s. Epitome Builders Pvt Ltd, herein after referred to as the applicant(s) at location of the property bearing Khatha No. 1963, Sy. No. 171/3 & 172/5, Kothnur Village, Uttarahalli Hobli, Bangalore South Taluk, Ward No.194, Bangalore [Within the area bounded by Geographical Coordinates: N12°52′27.54″ E077°34′30.02″, N12°52′26.76″ E077°34′30.06″, N12°52′26.89″ E077°34′31.85″, N12°52′26.06″ E077°34′33.56″, N12°52′27.19″ E077°34′33.54″] to height 52 Mts. (Fifty Two Only) ABOVE GROUND LEVEL, so that the top of the proposed structure when erected shall not exceed 981.3Mts.AMSL (ABOVE MEAN SEA LEVEL), i.e. 929.3Mts (Site elevation) + 52 Mts (Height of the structure).

3. This No Objection Certificate is being issued on the express understanding that the site-elevation reduced level (height above mean sea level) vis. 929.3Mts AMSL relative location of the proposed building/structure and its distances and Bearings from the ARP, Runway ends as tendered by the applicant(s) are correct.
