Invites applications for the following Tenure based (2 years) Teaching posts at **HAL New Public School, Bangalore** for the Academic Year 2019-20.

1. PRT-English : One Post

Qualification: Graduate with English as one of the main subject in Graduation and B.Ed. with English as one of the teaching methods.

2. PRT-Social Studies: One Post

Qualification: Graduate with two subjects out of History, Political Science, Economics, Sociology, Geography OR Hons. Graduate with History or Political Science or Geography as a main subject and B.Ed with any one subject as mentioned in Graduation.

3. TGT-English : One Post

Qualification: B.A. with English as one of the main subject in all three years of Graduation and B.Ed. with English as one of the teaching methods. Preference will be given to candidates with MA (English).

Pay:

- Rs.25,500/- + Admissible DA from time to time for posts at Sl.No. 1 & 2.
- Rs.29,200/- + Admissible DA from time to time for the post at Sl. No. 3.

Age: Maximum of 45 yrs as on 01.06.2019 for all the above posts.

Please Note:

1. Experience of 2 years in teaching in Middle/ High School level (VI to X) in CBSE/ICSE Schools for TGT level posts is required whereas experience is not mandatory for PRT level posts. However, preference would be given to candidates with experience in CBSE/ICSE Schools even for PRT level posts.
2. Candidates must have secured an aggregate of 50% in Graduation and 50% in teaching subjects in B.Ed course.
3. Candidate applying for posts in English & Social Studies, medium of instruction in English will be required at School and Graduation level.
4. Integrated course offered by Regional College of Education would be equated with Graduation and recognized Degree/Diploma in Education. However, candidate should be a Graduate in/with the subject in all the years for the post applied for.
5. Experience of one academic year refers to 10 months, excluding summer vacation.
6. Candidate must attach Experience certificate wherever applicable. In case of a candidate who is working at the time of submitting application, an Appointment letter and latest Salary certificate/Salary slip from the current employer will also be accepted in lieu of Experience certificate.

7. Only post qualification experience will be considered.
8. The selection will be done through Written Test, Demo and Interview. The date, time and venue of the Demo and Interview will be intimated to the short-listed/eligible candidates by E-mail/Telephonically.
9. Application with incomplete information or applications received after the due date will be summarily rejected.
10. Candidates who have already applied against our earlier advertisement dated 03.02.2019 need not to apply and their application will be summarily rejected. However, candidates who have applied earlier for the post of TGT (English) are eligible to apply again.
11. Candidates meeting eligible to the eligibility criteria may send their application strictly in the prescribed format which is available at HAL Website(www.hal-india.com) along with non refundable Demand draft of Rs.200/- drawn on any Nationalized Bank in favour of '**Secretary –HAL New Public School**'. Internal candidates of HAL New Public School are exempted from payment of Application fee.
12. Copies of testimonials pertaining to qualification (SSLC, PUC, Graduation, Post Graduation & BEd.), Age, Experience certificate/Appointment letter along with latest pay slip, recent passport size photograph (2 nos.) etc. are mandatorily required to be enclosed along with application.

14. The Application has to be sent through Ordinary Post/Speed Post/Registered Post/Courier only. Applications received through other modes viz., Fax/E-mail etc. will not be accepted and will be summarily rejected. No application will be received in person on the address mentioned above. Applications received after the due date will not be considered.
15. Any sort of canvassing or influencing the Officials related to the recruitment/Selection Process would result in immediate disqualification of the candidate.
16. The Decision of School Management is final on all matters.
