Sub: Update on Indefinite Strike by Workmen Unions of the Company

This is further to our letter no. CO/SEC/4(7)/2019/ BSE & NSE Filing/26 dated October 1, 2019 on the subject "Intimation of notice of Indefinite Strike by Workmen Unions of the Company".

2. Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that:

(a) Hon'ble High Court of Karnataka has passed an Interim Order on October 22, 2019 restraining the Hindustan Aeronautics Employees Association (HAEA), Bengaluru, its Office Bearer and Members/ Workmen from continuing the Strike including go slow, work to rule or any other form of agitation or disrupting day to day activities of the Company and its Officers in Bengaluru.

Based on the Interim Order of the Hon'ble High Court of Karnataka, HAEA, Bengaluru has called-off the Strike and the Workmen have reported to work in all Bengaluru based Divisions/ Offices from today, i.e. October 23, 2019;

(b) Workmen Unions at Kanpur & Barrackpore have also called-off the Strike and Workmen have reported to work from today;
