Engagement of Paramedical Specialist (Physiotherapy) on Part-time / visit basis for Industrial Health Centre (IHC), HAL, Koraput Division

1. Hindustan Aeronautics Limited (HAL) a Maharatna CPSE under Ministry of Defence is the premier Aeronautical Industry of the Nation. HAL is engaged into design, production, repair, overhaul and upgrade of Aircraft, Helicopters, Aero-engines, Accessories, Avionics and Systems. HAL has its presence across seven states and nine geographical locations in India.

2. ELIGIBILITY CRITERIA & REQUIREMENT:

a) The Koraput Division of the Company is located at Sunabeda, in Koraput District of Odisha. The Division has a full-fledged multi-specialty Industrial Health Centre (IHC) at Sunabeda. Applications are invited from interested persons to be engaged as **Paramedical Specialist (Physiotherapy) on Part-time / Visit basis**, at the Industrial Health Centre. 3. TENURE OF ENGAGEMENT:

The initial engagement will be for a period of 2 (Two) years. Further, extension of engagement may be considered based on performance of the Part-time Paramedical Specialist (Physiotherapy) and requirement of the Division.

4. TERMS & CONDITIONS OF ENGAGEMENT

- (i) The engagement of Part-time Paramedical Specialist will be purely temporary and it will not confer any right to claim the status of a regular employee of the Company under any circumstances.
- (ii) The Part-time Paramedical Specialist will not be entitled for any other Allowance or Benefits other than those indicated above.
- (iii) The Part-time Paramedical Specialist shall abide by the Company Rules & Regulations governing their engagement.
- (iv) The Part-time Paramedical Specialist shall safeguard the security and confidentiality of all official matters and secrecy of information coming to his/her knowledge.
- (v) The Part-time Paramedical Specialist will be covered under the Income Tax, Service Tax, Professional Tax etc. as per the applicable rules. All such Taxes would be deducted from the remuneration payable to him/her.
- (vi) Part-time Paramedical Specialist is required to visit the IHC of HAL Koraput on suitable days, as per the requirements of the Organisation, for providing treatment to the patients, on receiving intimation from Chief of Medical Services (CoMS). The Part-time Paramedical Specialist may also be requested to attend medical emergencies at IHC, HAL Koraput Division.
- (vii) The engagement of the Part-time Paramedical Specialist will stand automatically terminated/closed on completion of the prescribed tenure as specified in the Engagement letter. The engagement of Part-time Paramedical Specialist can also be terminated/closed even earlier, with one-month notice in writing, by either side or payment in lieu of notice (i.e consolidated remuneration equivalent to the amount payable for 7 visits).
