Remuneration for Visiting Doctors General Duty Medical Officer (GDMO) on Part Time basis:

- The Remuneration payable to the Visiting Doctors on Part time basis is Rs. 600.00 per hour for 06 hours per day (03 hrs in morning and 03 hrs in evening) for a maximum of 06 days a week. No Conveyance charges will be reimbursed.

Selection Procedure:

- Shortlisted eligible candidates will be called for interview. Date, time and venue of the interview will be intimated to the shortlisted/eligible candidates via E-mail/post. Candidates shortlisted for interview are required to bring the certificates/documents in original as a proof of age, education qualification and experience at the time of interview for verification. No TA/DA will be admissible.

- The Visiting Doctors on Part time basis would be reporting to a designated regular Doctor in the Hospital of the Division;
- Upper age limit for engagement of Visiting Doctors on Part time basis is 65 years as on **30.04.2024**.
- The Visiting Doctors on Part time basis will not be entitled for any other Allowance or Benefits other than those indicated above;
- The Visiting Doctors on Part time basis are required to visit the Hospital of the Division on shift or as per requirement of the Organization for providing treatment to employees and their dependent family members. In the event of emergency, they may be called as and when required;
- No Leave (Casual Leave/ Vacation Leave) will be admissible. However, there will be no duties on paid holidays (except in case of emergency/requirement of the Company with remuneration) and no remuneration will be paid for the day.
- The initial engagement of Visiting Doctors on Part time basis will be for a period of 02 (Two) years. Further, extension of engagement if required, will be as per Company's policy.
- Residential accommodation (if available) will be provided in the Township and nominal charges will be deducted as per company rules.
- The Visiting Doctors on Part time basis will abide by the Company Rules & Regulations governing their engagement;
- The Visiting Doctors on Part time basis will safeguard the security and confidentiality of all official matters and secrecy of information coming to his knowledge;
