Note: * The experience would be relaxed on need basis in deserving candidates.

Qualification should be recognized by Medical Council of India. He/she should have valid MCI Registration under the Medical Council of India Act. Candidate possessing regular/full time qualifications prescribed above is only eligible to apply. In other words, the qualifications acquired through part time/correspondence/distance education/E-learning course are not eligible to apply.

AGE LIMIT:

Upper age limit is 65 Years as on the date of Advertisement. No further relaxation is admissible.

PERIOD OF ENGAGEMENT:

The Specialist will be engaged for a period of two years, Performance of the Specialist will be assessed by the Head of the Hospital during the said period. They will be reporting to the Head of the Hospital.

Suitable candidates from amongst the applicants will be shortlisted for Interview. Personal interview will be conducted at Industrial Health Center, HAL, Ojhar Township. Final selection will be made based on the performance in the Interview.

Candidates are required to possess a valid E-mail ID, so that intimation regarding interview can be sent. HAL will not be responsible for bouncing of any E-mail sent to the candidates by E-mail. The exact timing of the Interview will be intimated to the candidates through e-mail.

REMUNERATION:

In addition to the remuneration per visits, the Visiting Consultants (General Surgeon) performing surgeries would be paid an extra amount of Rs. 1400/- per surgery. The surgery would be conducted during the period of their regular visiting hours only.

With per visit consultation charges / remuneration (fixed by HAL) / surgery fees, the selected candidate will be eligible for Conveyance reimbursement (per visit) as applicable rules of HAL at the time of engagement.
