HAL and Israel Aerospace Industries Sign MoU for MMTT

Bengaluru/New Delhi, April 6, 2022: In a move aimed at bolstering the 'Make in India' campaign, HAL has entered into an MoU with Israel Aerospace Industries (IAI) to convert Civil (Passenger) aircraft to Multi Mission Tanker Transport (MMTT) aircraft in India. Under the pact signed recently, HAL will convert pre-owned Civil (Passenger) aircraft into air refueling aircraft with cargo and transport capabilities.
